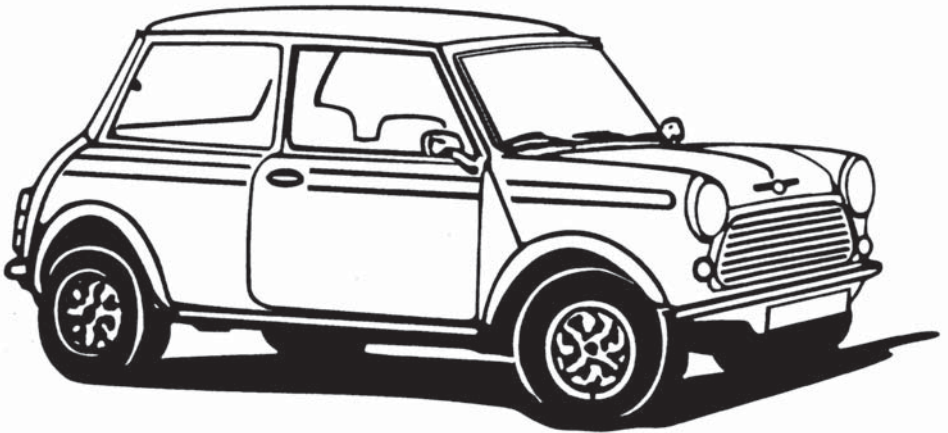

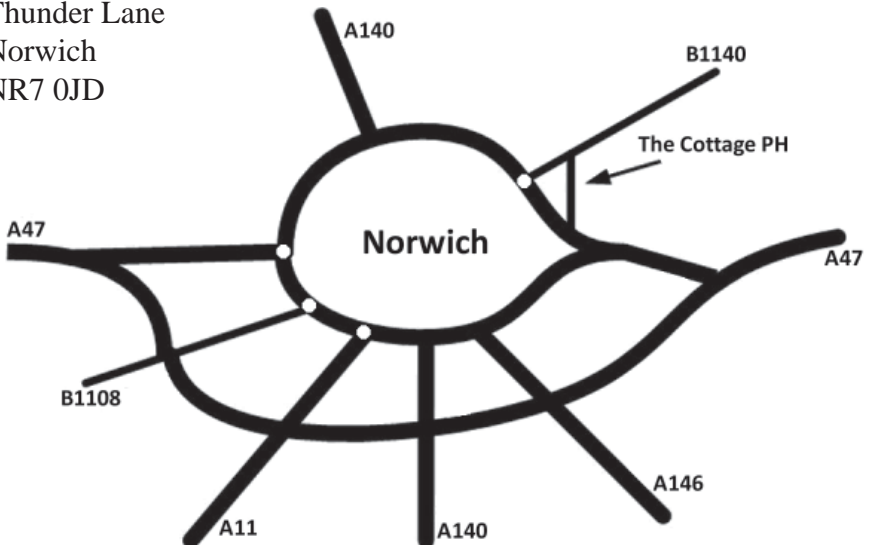

## **A message from the Committee**

Thank you for your enquiry about joining our club. Norfolk Mini Owners Club is a means for like-minded people to socialise and enjoy the Mini scene. We welcome owners of both BMW and Classic Minis though ownership is by no means essential to join the club, merely an interest in the little British car.

We meet at 8pm on the first Tuesday of every month at The Cottage PH in Norwich (see map opposite) where we hold a short informal meeting usually lasting between one and two hours. We discuss upcoming events, take suggestions for future events and most months we organise some kind of activity ranging from bingo and quizzes to Mini parts auctions and scrapheap challenges!

The meetings are also a chance for members to get together and talk about Minis, swap stories and give each other mechanical advice when needed, which can be quite often!

As well as activities at the meetings, we also organise and attend events on the local and national Mini scene (and occasionally overseas!) - take a look overleaf for a few examples of what we get up to.

The club also exists to support charities suggested by club members, currently we are supporting the East Anglian Air Ambulance but have also made donations to local childrens charities, the RNLI and a women's refuge.

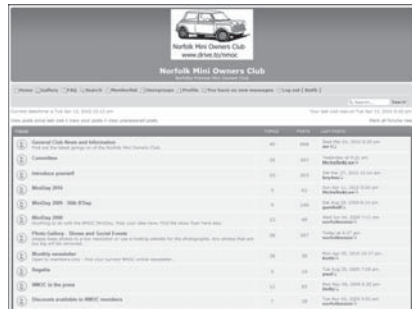

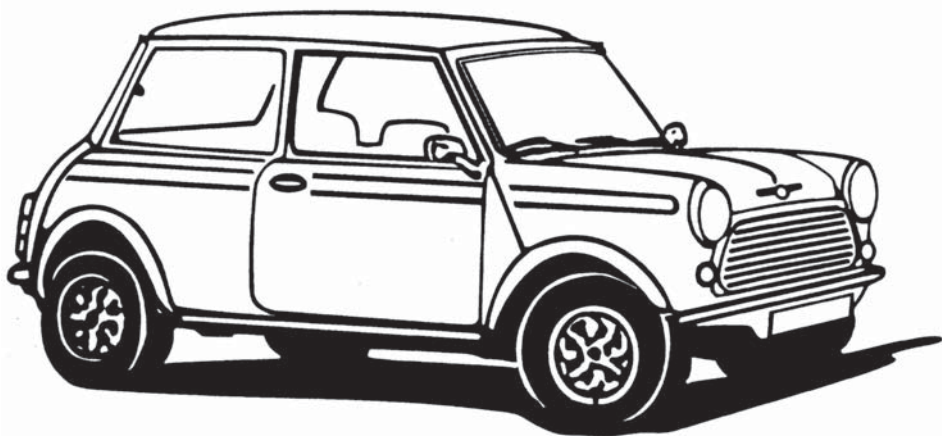

# Norfolk Mini Owners Club Constitution and Rules

January 2010

## 1. Title.

The name of the club shall be the Norfolk Mini Owners Club hereinafter be referred to as NMOC.

## 2. Objectives.

- To promote interest in and preserve Minis and Mini derived vehicles irrespective of age and condition.
- To provide members with information and advice on matters relating to Mini motoring.
- To provide members with a calendar of social events, tours and discussions.
- To provide members with benefits and privileges as it may be possible to arrange.
- To, where possible, raise monies for Charity.

## 3. Membership.

Membership is open to all and shall consist of Single, Joint, Family and Honorary. Members are to have an interest in the objectives of the NMOC and ownership of a Mini is not necessary.

## 4. Management.

The authority and responsibility for the transaction of business of the club shall be vested in a committee. Elected at the AGM for a 12 month period, retiring committee members have eligibility for re-election.

## 5. AGM.

The AGM of the Club shall be held on the first Tuesday in June and open to all members. The AGM shall:

- Receive from the Treasurer a statement of receipts and expenditure for the year ending 31st March.
- Receive from the committee a report of the NMOC activities during the year
- Elect the committee to replace those retiring.
- Decide on any resolution submitted by the members to the Chairperson or Vice Chairperson at least 14 days before the meeting.
- Provide minutes of the AGM to all members.

## 6. Voting.

Every member has the right to be present at the AGM if subscriptions at that

date are paid up. At the AGM each member of the NMOC has one vote to cast for each committee position.

## **7. Committee.**

The committee consists of the following members:

Chairperson  
Vice Chairperson  
Event Organiser(s)  
Treasurer  
Public Relations Secretary  
Magazine Editor  
Regalia Organiser

Additional 'helper' members may be elected as directed by the committee. The above named positions may be amended as and when necessary, at the discretion of the committee.

## **8. Meeting of the Committee.**

Frequency as directed by the Chairperson and attended by Chairperson or Vice Chairperson (normally the 2nd Tuesday of each month) and any paid up members are welcome to attend as observers.

## **9. Committee Voting.**

Each committee member present shall exercise one vote.

## **10. Banking.**

The Treasurer shall bank all monies of the NMOC and will provide details of the club accounts within 14 days of request. Payments from NMOC funds must be countersigned by two signatories, which shall consist of the chairperson and one of two other committee members decided at the first meeting after the AGM. All signatories must be unrelated by birth or marriage.

## **11. Subscriptions.**

Subscriptions shall be for one year from the first day of the month of joining. The committee may recommend variation in the rate as deemed necessary. Membership of other clubs does not entitle an applicant to membership at a reduced rate.

## **12. Honorary Members.**

Honorary Membership shall be offered to any person at the discretion of the committee.

### **13. Non payment of subscriptions.**

Any member of the NMOC, who has not paid his/her subscription one month after the due date, shall be notified by the Membership Secretary of this fact. One month thereafter any member who has still failed to pay shall be struck off the register of members, at the discretion of the committee.

### **14. Termination of Membership.**

Any member ceasing voluntarily or otherwise to have NMOC membership shall cease to have claim on the privileges of membership but shall remain liable for any debts due to the NMOC from him/herself.

The committee reserves the rights to expel any member of the NMOC whose actions are deemed against the good name of the NMOC. Any member whose expulsion is under consideration shall be given at least 14 days notice of this fact and shall be allowed to offer an explanation of his/her conduct verbally or in writing. If two thirds of the committee vote for his/her expulsion, he/she shall cease to be a NMOC member. Any subscription monies paid for the current remaining year will not be refunded.

### **15. Use of the Club Name and logo.**

The NMOC name, in conjunction with the name and/or address of any member shall not be given for any trade, advertising or business purposes or in conjunction with any legal proceedings of that or any other member unless approved by the committee.

### **16. Data Protection.**

All personal details of all members will not be shared with any third party without the permission of the member.

### **17. Observance and Interpretation of the Rules.**

Every member binds him/herself to abide by the rules of the NMOC and shall accept the decision of the committee in all cases of dispute and disagreement as final and binding. Rules may be altered provided that two thirds of the committee are in agreement.

### **18. Dissolution.**

The NMOC may be dissolved by a Special General Meeting convened by the committee or at the request of the majority of the members. If duly passed the committee shall forthwith liquidate the affairs of the NMOC and any surplus assets disposed of at the discretion of the committee.
